## Applicability

Processing of your personal data can in that case take place without your permission, provided this is necessary for the execution of an agreement to which you are or become a party, or necessary for the representation of the legitimate interests of No Point Airport & Studio. In addition, there may be a legal obligation on us to process your personal data.

We process your personal data for the following purposes:

- To be able to call or email you if necessary.
- To process your manual payment via Bank Transfer or PayPal.
- For generating an accurate address label to deliver the order to you.
